 - e. Jim Holder made a motion to accept the renewal for the continuation of the Texas Early College High School for the 2023-24 school year. Polly Maines seconded it. It passed unanimously.
 - f. Jim Holder made a motion to accept the renewal for the continuation of the Panola Early College High School. Polly Maines seconded the motion. It passed unanimously.
 - g. Mr. Worley gave an updatae on the TEA grant for safety in schools. He told them he had gotten bids on the glass protection for all windows and doors.
